Recognition of Visitors - Comments or Requests to Speak

Seventeen visitors attended the board meeting with a handful who addressed the board. Those who addressed expressed their concerns regarding the high amount students being quarantined due to the district following CDC guidelines in response to COVID-19. Parents expressed their concerns with the large number of healthy students who need to quarantine, the number of disruptions in learning, and student isolation.

Board Action: Superintendent Dr. Doug Wheeler made a recommendation to the Board to follow the Iowa Department of Health Guidelines in response to COVID-19 and when to quarantine. The Board approved the recommendation to follow the Iowa Department of Health Quarantine Guidelines in response to COVID-19.
