At the April 12, 2021 early work session, School Board members received a Behavior Data Analysis Report from the Executive Director of Learning Supports.

Jeri Moritz, Executive Director of Human Resources and Equity, presented the results from the Fall 2020 School Perceptions Staff Survey. The Staff Survey was conducted in late October through early November of 2020. 51% of staff members responded to the survey. Teachers represented the largest group of respondents.
